EIPS and EICS presented on January 26, 2016 to Strathcona County Council Priority's meeting to formally request that Council review the effective time for school zones to be 8 am to 4:30 pm for urban schools and 7:30 to 4:30 for rural schools.

Trina presented at the Vegreville Chamber of Commerce on February 10<sup>th</sup> and the Sherwood Park Chamber of Commerce on February 11<sup>th</sup> and will be at Lamont County on March 10<sup>th</sup> to share information and answer questions about EIPS. The goal is to hear what skills and knowledge students need to have to prepare for the world of work.

The **March 17<sup>th</sup> EIPS board meeting** will be in the evening (6 pm start for public portion) and five parent councils are invited to present to the School Trustees on advocacy partnerships, health schools, mental health and parental involvement.
